- Rental of Limousine is with full acknowledgment and agreement of the following terms and conditions, we require a major credit card to process reservations.
- There is no extra charge for the first 15 minutes of overtime. After 15 minutes you will be charged for one hour. No possession, sale or consumption of any type of narcotics or illegal drugs is permitted. Violations will result in immediate termination of contract and services with no refund. No SMOKING or EATING. Client and renter are responsible for his/her guests, for any damage to the interior and equipment of the vehicle. This is including but not limited to: gum, wine and alcohol spillage, vomiting (\$300), breakage of champagne, wine and drink glasses (\$10), decanters(\$50). Damage to lights, television, DVD, radio, CD player will have a minimum charge of at least (\$300.00) dollars. All passengers agree to behave in an orderly and well-behaved manner. We reserves the right to expel any person from the vehicle and/or terminate this contract in the event of a violation of any of these conditions by any passenger. In the event of such early termination, no portion of payment will be refunded. We are not responsible for items that are left in the vehicle during or after completion of the limousine rental period. We shall not be held responsible for late arrival caused by (but not limited to) acts of nature, traffic delays, breakdown, incorrect pickup and drop-off information, and any situation beyond our control. In the event any part of this contract is declared unenforceable, the remaining provisions of this agreement shall remain in full force and effect. Limousine rental must be made and this agreement signed by a parent or legal guardian. A down payment is required at the time of booking and is non-refundable. You must have the deposit credit card at time of pick up so the driver can get an imprint and signature if needed. The remaining balance will be charged within 24 hours of service. Payment due in full if canceled within 48 hours of service. We reserve the right to substitute the limousine for one equal to or larger, color requests are met at the best of our ability and not guaranteed.
- For school dance events including but not limited to Prom & Homecoming alcohol is prohibited. If alcohol is found within the vehicle the trip will be immediately terminated and the trip charges are non-refundable. For Prom and other school dance events I understand that Advantage Limousine Services will be providing transportation for minors and parental permission is required on all transportation without adult supervision for minors under the age of 18 years old. By signing this agreement I understand that it is a complete and full release of all claims regarding the transportation. I am authorized and have full authority to sign this agreement on behalf of all parents and guardians to release Advantage Limousine Services and all agents and owners from all claims and liability. This contract also serves as a credit card authorization form. By signing below, I acknowledge the charges listed on the general contract. In the event of passed cancellation deadline, I authorize Advantage Limousine Services to charge the full reservation fee. I read and agreed to all the cancellation guidelines (terms and conditions) that apply to my reservation. I understand that I am liable for any late fees, cancellation fees, or other charges. I will not dispute this charge. Payment based on Advantage Limousine Services general contract is made to be in accordance with the issuing card policies. I am my obligations under the card member's agreement.
